THESE PRICES ARE EFFECTIVE AS OF JANUARY 1, 2019

*The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.*

#### **BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF**

Our fee for the basic services of funeral director and staff includes, if applicable, but is not limited to: \$1,995.00

- Responding to the initial request for service 24 hours per day / 365 days per year.
- Conducting the arrangement conference.
- Preparation of biographical and statistical data.
- Examination of financial settlement options.
- Preparation and filing of papers, permits, and authorizations (within Monmouth County).
- Coordination with those providing other portions of the funeral (i.e. cemetery, clergy and others).
- Preparation and placement of obituary notices (if requested).
- Retention and care of remains prior to commencement of post death activities.

*This fee for our basic services will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)*

#### **EMBALMING** *(Including use of preparation room and sanitary care)*

*Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.*

*If you choose to have embalming performed, the decedent may be embalmed at a location other than this registered mortuary.*

*No human remains may remain unburied or uncremated in New Jersey for more than 48 hours unless embalmed or refrigerated. (N.J.A.C. 8:9-1.1)*

## OTHER STAFF AND RELATED FACILITIES

1. Use of facilities, staff and equipment for Viewing/Visitation.
  - Our services include setup of the visitation area, placement of remains, positioning of floral displays, and supervision and attendance during the hours of visitation.
    - a. Private family viewing (1st hour) \$550.00
    - Each additional hour \$275.00
    - b. Visitation immediately prior to funeral (per hour) \$275.00
    - c. One full day visitation or part there of \$1,100.00
  
2. Use of facilities, staff and equipment for Funeral Ceremony.
  - Our services include coordinating the arrangements for the ceremony, staff supervision and attendance, and the use of the funeral home when used for the ceremony.
    - a. At funeral home \$895.00
    - b. At funeral home, to church \$995.00

3. Use of staff and equipment for the accompaniment of the body to the place of final disposition.
 

***The State of New Jersey requires that a licensed funeral director accompany the decedent to the place of final disposition: No interment, disinterment, cremation or other disposition of a dead human body shall be made in the State of New Jersey unless a New Jersey licensed practitioner of mortuary science or funeral director is present at the time of disposition. (N.J.A.C. 13:36-8, 10)***

  - Accompaniment to the place of final disposition and, if desired, the use of funeral home equipment and staff for conducting a committal ceremony at the cemetery, mausoleum, or crematory.
    - a. Local (within 10 miles) \$350.00

4. Use of staff and equipment for Graveside Service (whether at cemetery, mausoleum or crematory).
  - Our services include the required accompaniment, supervision, and arrangement of the funeral service at the cemetery, mausoleum, or crematory, with no other public service.
    - a. Local (within 10 miles) \$500.00
    - b. Additional charge per hour outside local area \$175.00
  
5. Use of facilities, staff, and equipment for Memorial Service (Without body present).
  - Our services include coordinating the arrangements for the memorial services, staff supervision and attendance, and the use of the funeral home for a period of 3 hours when used for the memorial service.
    - a. At the funeral home (weekday) \$1,100 .00
    - b. At the funeral home (weekend or legal holiday) \$1,200.00
    - c. At other local facility (within 10 miles) \$550.00
    - d. Additional charges per hour beyond allotted time \$275.00

  - This charges will be applied only on days when no post-death activities occur, and the funeral home is in possession of the remains or cremated remains.

### FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME \$2,320.00

This package charge includes local removal of remains to this funeral home, basic services of funeral director and staff and obtaining necessary permits. It does not include a casket or alternative or shipping container, the use of facilities and staff for any visitation or ceremony, public or private, prior to forwarding the remains, or any sheltering for days on which no post death activities occur. Nor does it include transferring the remains to the airport or other destination, or the charges of a common carrier, or anything not expressly stated as being provided.

### RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME \$2,775.00

This package charge includes receiving the remains from the other funeral home, the basic sheltering of the remains, basic services of funeral director and staff, the obtaining of necessary permits and authorizations, accompaniment to the place of final disposition, and local (within 10 miles) transportation to the cemetery or crematory, via hearse. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial or cremation, or any sheltering for days on which no post death activities occur. Nor does it include transferring the remains from the airport or other source, or the charges of a common carrier, or anything not expressly stated as being provided.

### IMMEDIATE CREMATION \$1,920.00 and Up

Our package charges for immediate cremation, without any attendant rites or ceremonies, include limited basic services of funeral director and staff, the local (within 10 miles) transfer of remains to the funeral home, the basic sheltering of the remains, the obtaining of necessary permits and authorizations, accompaniment to the place of final disposition, and local transportation to the crematory, via service vehicle. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to cremation, or any sheltering for days on which no post death activities occur. Nor does it include the actual cost of the cremation process, which is a crematory charge, or any other cash disbursements, or anything not expressly stated as being provided.

*If you want to arrange a direct cremation or direct burial, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). \*The containers we provide are corrugated cardboard with wood sheet bottom, unlined. \*\*The use of alternative containers is limited by size and weight limitations.*

### IMMEDIATE BURIAL \$3,405.00 and Up

Our package charges for immediate burial include basic services of funeral director and staff, the local (within 10 miles) transfer of remains to the funeral home, the basic sheltering of remains, the obtaining of necessary permits and authorizations, sanitary care and preparation of remains for identification, accompaniment to the place of final disposition, and local transportation to the cemetery via hearse. This charge does not include embalming, the use of facilities and staff for any visitation or ceremony, public or private, prior to burial, or any sheltering for days on which no post death activities occur. Nor does it include the actual cost of the grave at the cemetery, or the cemetery's charges for opening and closing of the grave, any required outer burial container or cash disbursements, or anything not expressly stated as being provided.
